Base charge, zero usage	\$20.49	per REU based upon sewer design requirements;

NON-RESIDENTIAL USAGE CHARGE (per 1,000 gallons)

Water budget amount varies base on REU rating

Tier 1 (= or < water budget amount)	\$5.78
Tier 2 (Usage > water budget amount)	\$9.48

IRRIGATION (per 1,000 gallons) \$9.48

MONTHLY NONRESIDENTIAL SEWER:

100% of water charged \$64.66 (minimum)

DEBT/CAPITAL SURCHARGE FEE:

Rate is per Residential Equivalent Units (REUs) \$14.61

NEW CUSTOMER ACCOUNT SETUP FEE:

Water Utility Service: \$17.38

Sewer Utility Service: \$17.38

Note: If water and sewer utility services are established at the same time, only a single \$17.38 charge will apply.

RECONNECTION CHARGE:

If water service cut off by Utilities for good cause: \$57.93

If water service discontinued at the customer's request: \$57.93

If sewer service is cut off by Utilities for good cause: \$57.93

Note: If water and/or sewer service is disconnected and service is reconnected within nine (9) months, the base charges and surcharge for all months disconnected will be due and payable.

OTHER CHARGES AND TERMS:

Non-sufficient funds (NSF) check charge: \$26.53

Bills due: On billing date.

Bills Past Due: (20) days after billing date

Billing Frequency: Shall be monthly for service in arrears

Finance Charges for Late Payment: 1% per month will be applied to the unpaid balance of all bills still past due 21 days after billing date

Collection Agency Fee: 35% of any unpaid balance will be applied to the account, if account is turned over to a collection agency

Labor, work-hour services: \$39.35 / hour

Labor, after-hour services: \$55.74 / hour

Equipment use charges: \$61.20 / hour

Portable Toilet / Hand Wash Station rental charges: \$127.88 / Month \$66.68 / per Event
