## **Proclamation of State of Emergency – First Amendment**

**WHEREAS**, in response to the COVID-19 (novel coronavirus) pandemic, the Village of Bald Head Island, North Carolina proclaimed a State of Emergency on March 19, 2020; and

**WHEREAS**, the Village's Proclamation of March 19, 2020 is incorporated hereby by reference; and

**WHEREAS**, the Village has determined it necessary to take additional preemptive measures to reduce the impacts of COVID-19; and

**WHEREAS**, imposing the restrictions and prohibitions ordered herein is necessary to maintain order and protect public health, safety, and welfare.

**NOW, THEREFORE,** pursuant to the authority vested in the Mayor by Chapters 160A, 166A and 14 of the North Carolina General Statutes, as well as Chapter 8 of the Village Code of Ordinances, I, J. Andrew Sayre, Mayor of the Village of Bald Head Island, do hereby proclaim and impose the following orders, prohibitions and restrictions:

- 1) **Prior Proclamation:** The Village's Proclamation of State of Emergency of March 19, 2020 is ratified, reaffirmed and shall continue in full force and effect.
- 2) Construction Activities: All construction on the Island, residential and commercial, shall cease by 3:00 P.M. on Saturday, April 4, 2020, with the exception of those essential services on the list attached hereto as <u>Exhibit A</u> and incorporated herein. Village officials, in the interest of public health, safety and necessity, may amend <u>Exhibit A</u> from time to time. Unless modified or extended, the prohibitions and restrictions in this Section 2 shall expire at 5:00 P.M. on Saturday, April 18, 2020.
- 3) **Emergency Area:** The emergency area covered by this State of Emergency shall be the Village's entire corporation jurisdiction.

This Proclamation is effective upon signature.
