The special meeting is being called by the Chair of the Board pursuant to Article III, Section 2 of the Bylaws of the Authority. At the meeting, the Board will also hold a public hearing during which it will receive public comments. The matters to be heard or considered at the special meeting are the Authority's proposed acquisition of the Bald Head Island Ferry System and the issuance of revenue bonds therefor. The meeting will include an initial presentation of information about the acquisition of the System and the bonds, followed by a public comment period.

The total public comment period will be limited to 90 minutes, and each speaker will be limited to three (3) minutes. To the extent multiple speakers wish to make a similar point, please consider allowing one person to speak on behalf of the group. If you join the meeting by telephone, you will be able to listen to the meeting but will not be able to speak.

All written comments will be available for review by the public (on the websites mentioned below) and delivered to the Trustees. Comments will be received prior to the meeting and up until 3 p.m. on February 18, 2021.
