RE: Golf Cart Registration Renewals for 2026

Dear BHI Registered Golf Cart Owner,

The Village of Bald Head Island is making its golf cart registration renewals a more seamless process for golf cart owners starting in 2026.

Registration Invitation: All Islanders with current 2025 registrations will see enclosed a registration invitation from our vendor. This invitation includes a list of all registered carts that are under the same name and mailing address. The invitation includes a link to access this information online.

- Owners will be able to verify/update insurance information, make, model, serial numbers, etc. for the carts they own and will need to renew for 2026 through 2027.
- The original registration date for each cart will be listed.
- There will be an attestation statement in which the owner will attest that the vehicle meets all equipment and specifications per the Village ordinance.
- The owner will then select the cart(s) that need to be registered and then pay for the registration renewal.

Change of Ownership: If you receive this letter and you have transferred ownership of a cart/carts to another person who is likely driving the cart on BHI, please let the Village know as soon as possible. Please email psadmin@villagebhi.org or call 910-457-5252 (press 1 for administrative assistance).

Prorated Fees: To ensure a smooth transition to the new system and minimize confusion, the Village will apply a one-time prorated fee based on the golf cart's original registration date. This fee will include a prorated amount for the current fiscal year (FY 26) and the full amount for the next fiscal year (FY 27). This single payment will cover the registration period through the next renewal date in 2027, eliminating the need for multiple payments or steps. For example, if your cart's original registration date was April 15th, you would pay a renewal fee of \$40. This amount includes a prorated fee of \$10 for January through April 2026 and \$30 for May 2026 through April 2027. You can view the fee schedule on the table on Page 2 of this letter.

New Carts would pay \$30 at time of registration and would be good for 12 months.

New Carts: New carts purchased after implementation of the new system will be registered online through our vendor. This information will be made available on the Village website. In lieu of visual inspections at the Department of Public Safety, the owner will be required to attest that the cart meets the specifications in the Village’s Code of Ordinances. The new owner will only pay for the first year (\$30) at the time of registration, and it will expire in 12 months.
