For each golf cart/electric vehicle you register, you, as owner, must agree to the following statement:

I hereby attest that the personal-use electric vehicle being registered meets all equipment and specifications set forth in the Village of Bald Head Island Code of Ordinances Section 28-53. I understand if this personal-use electric vehicle is found in non-compliance of the equipment and specification requirements, the registration will be revoked and collected by Public Safety.

Stickers will be mailed to the address you specify in the online application. Please note that there may be a delay between the processing of your application/payment and the mailing of your new stickers. We appreciate your patience as we transition to this new system. Registrations are due by January 1, 2026, and we encourage vehicle owners to register on time despite any delays. The Village will monitor processing timeframes and determine an appropriate time to begin enforcement for expired registrations. Each registered cart will receive four stickers: two large ones to be affixed to the front of the cart and the driver's side rear panel, and two smaller stickers to be placed in the upper right corner of the large stickers.

The annual cost of a sticker is \$30.00.
